

## **GURGAON AS A SMART CITY**

# Conference Objectives

- In the last two decade or so, Gurgaon has witnessed unprecedented growth and transformation. From a sleepy little town, it had
  metamorphosized into a modern, pulsating city with plush offices, malls and hi-tech residential complexes.
- However, rapid growth has led to its own set of problems. Gurgaon's population has doubled in the last five years putting substantial
  pressure on city's resources. Infrastructural bottlenecks including traffic snarls, road congestions, power cuts, water scarcity and
  pollution are on the rise.
- There are notable developments as well. New state-of-the-art infrastructure be it hospitals, schools, offices, hotels, residences have sprung up. The metro has instantly improved connectivity and transportation. The upcoming Rapid Metro Rail in Gurgaon (first private metro system in India) is further set to take commuting standards to the next level. Infrastructure developers are creating sustainable residential and official spaces that minimize the use of energy and improve efficiency.
- Clearly, there are islands of excellence. However, Gurgaon is still far away from being an efficient, smart, intelligent city that conserves
  costs, water, energy and uses technology as a way to interconnect and coordinate various city services and manage the overall
  functioning of the city.
- Progressive cities across the world are rapidly adopting measures and technologies that will help them to become more efficient and sustainable. The objective is to plan better, use resources more optimally, manage city's administrative processes and functions efficiently and respond quickly to emergency situations.
- Gurgaon must also take the right steps. It must use technologies, solutions and best practices to strive towards providing a better living and working experience. The city's agencies and departments need to be better networked and there needs to be greater coordination.
- The mission of this conference is to bring together Gurgaon's policy makers, planners, corporates, business leaders and managers, residential and civic bodies on one platform to deliberate on how best to move towards making Gurgaon a smarter place to live and work. The conference will take note of all the positive initiatives and developments that are happening in this direction, both by public and private entities. It will also highlight the technologies that will help us achieve this goal and the companies that can help in being the agents of change.
- Specifically, the conference will address questions like :
  - Why is it important for Gurgaon to make the smart moves?
  - What are some of the learnings from other cities in India and abroad that can be put into practice?
  - What are various current public and private initiatives/projects that are helping Gurgaon operate efficiently?
